To file for divorce in Hawaii, either your spouse or you must be either physically present or domiciled in the state for 6 months continuously before filing for divorce. After this period, the court order is nullified and you will be required to take the next step in your marriage, which is in most cases divorce. Hawaii Divorce Laws - FindLaw Hawaii is a “no-fault” divorce state, which means that if one person or the other wishes to get the divorce, it will go through. This means that no specific reason for the divorce must be given by the spouse requesting the divorce at the time of filing, other than that the marriage between

the spouses is “irretrievably broken.” Hawaii Family Law Help and Advice Hawaii Legal Separation: Legal separations are allowed in Hawaii when the court finds the marriage is temporarily disrupted. A petition for separation is required, and two years is the maximum time period granted. Hawaii Divorce & Separation - FreeAdvice Hawaii is a “no-fault” divorce state. This means that it doesn’t matter who did what to whom, or who is to blame for the divorce. If spouses separate for two or more years, or one spouse states in the paperwork that the marriage is “irretrievably broken” (meaning, it's beyond salvation), then a judge will grant the divorce.
